**CIRCULAR**

**Sub: Revised admission schedule for Entry Level Classes: (Nursery/KG/1<sup>st</sup>) for open seats in Private Unaided Recognized Schools of Delhi for the session 2017-18.**

- I. In continuation of this Directorate's Circular No.DE (172)/PSB/2016/77 dated 19-12-2016 and No.DE(172)/PSB/2016/12684-12695 dated 09-01-2017, the revised admission schedule for Entry Level Classes (Nursery/KG/1<sup>st</sup>) for open seats in respect of **Private Unaided Recognized Schools of Delhi** for the session 2017-18 (excluding schools which have been allotted land by DDA/Other Govt Land Owning agencies) shall be as under:-

4	The date for displaying the first list of selected candidates (including waiting list, along with marks allotted under point system)	07-03-2017 (Tuesday)
5	Resolution of queries of parents, if any by written/email/verbal interaction) regarding allotment of points to their ward in the first list.	08-03-2017 to 10-03-2017
6	The date for displaying the second list of selected candidates, if any (including waiting list along with marks allotted under point system)	17-03-2017 (Friday)
7	Closure of admission process.	31-03-2017 (Friday)

**Note:** In view of interim order dated 20-01-2017 passed by the Hon'ble High Court in WPC 408/2017 and WPC 409/2017, the above schedule shall also be applicable to the Minority Schools running on the land allotted by the DDA/Other Land owning agencies with the condition to ensure admission in neighborhood.

- II. For the schools running on the land allotted by DDA /other Govt Land owning agencies (except Minority Schools) with the condition to ensure the admission in neighbourhood, for which the admission schedule was issued, vide this directorate's Circular No. DE(172)/PSB/2016/12672-12683 dated 09-01-2017, the last date of submission of applications is also extended to 14-02-2017. The date for the display of first list and second list shall be 07-03-2017 and 17-03-2017 respectively. The admission process shall be finally closed on 31-03-2017.

In this regard, it is clarified that as per the directions of the Hon'ble High Court dated 13-01-2017 in WPC 272/2017 titled as Action Committee Unaided Private Recognized Schools Vs DDA & Ors. And WPC 275/2017 titled as Vikram Dev Raj & Ors. Vs Lt. Governor of Delhi & Anr., the parents shall fill the forms in the prescribed format and the criteria mentioned therein by the respective such schools. However, the format of form of such schools shall also contain the criteria mentioned in the impugned notification dated 07-01-2017 regarding neighborhood. But, the scrutiny of these forms is subject to further orders to be passed in the present writ petitions.

The subsequent date lines for the intermediate stages of admission procedure in respect of such schools shall be issued subject to the outcome of the writ petitions.
