1 Definitions :

In this agreement "I", "You", "Your" means and refers to the person who has applied to "Xcapade Adventures" to be enrolled and whose application has been accepted by "Xcapade Adventures Pvt. Ltd." for undertaking activity/activities at Xcapade Adventures. "Us", "Our(s)" or "XAPL" means Xcapade Adventures Pvt. Ltd. "Facility" means and refers to the premises or the land under the occupation and control of Xcapade Adventures for the purpose of conducting the said adventure activity / activities. "Guardian" means and refers to the natural parents of the minor child or such other person entrusted with the custody of the child by the natural parents or by law. Unless contrary to the context, the persons mentioned in the paragraphs above are collectively referred to as "Parties".

2 Do's & Don'ts:

Your safety is our prime concern. It is imperative that you understand that all the activities at Xcapade Adventures are adventure sports and therefore necessary precautions must be taken here.

You hereby agree to abide by the following:

- Wear any and all safety gear provided by XAPL for participating in the activity/activities.
 - Wear glasses/ contact lenses, in case you already use the same or have been advised by your doctor.
 - Use hearing aid(s), if you already use the same or have been advised by your doctor.
 - Take responsibility of any and all personal belongings.
- You hereby agree not to do the following:
- Consume alcohol and/or drugs during XAPL visit at Xcapade Adventures or participate under the influence of alcohol/drugs.
 - Damage in any manner, the equipment in any form and in particular shall not smoke or cause fire in the vicinity of the equipment.
 - Possess or cause anyone to possess any inflammable/explosive items or firearms at Xcapade Adventures.

3 Declarations:

- I hereby declare that given the nature of sport that I'm going to undertake, I'm of sound mind, nature and physical health.
- I further declare that I have attained majority and I'm fully competent to enter into this agreement.

4 Undertaking:

- I hereby undertake to abide by all the rules and regulations, issued by XAPL from time to time.
- I further undertake to follow any advise/instructions written and spoken that may be given to me by the XAPL instructors/staff, from time to time whether during the training sessions or during practice or otherwise.
- I further also undertake that I shall not do any act or say anything which disturbs or is likely to disturb the peace and well being of the guests/participants/staff of Xcapade Adventures or do any act which would offend the sensibilities of the other fellow participants of the activity/activities.
- I have been explained all the rules & regulations of the activity/activities willingly; fully knowing the risks involved and also agree to abide by all the instructions given by the Marshals. I hereby authorize the Marshals to refrain me from participating in the activity if I don't follow the instructions given to me by them. In such an event, I will not claim any refund.
- I assure and state that I do not have any medical problems including but not limited to any heart ailment, high blood pressure, back ailments, epilepsy, asthma or any other

conditions that may impair my ability to safely participate in the activity/ activities, and I am not pregnant.

- I am not currently undergoing any medication and nor am I under alcohol, narcotics of any kind or any other intoxicants which may impair my ability to estimate the risks involved in the activity/activities and to safely participate in the mentioned activity/activities.
 - I am not currently undergoing any psychiatric or psychological treatment or counseling for any condition that may impair my ability to estimate the risks involved in the activity/activities and to safely participate in the activity/activities.
 - I undertake to make good of any damage done to the equipment on account of accident caused due to my negligence. I hereby agree not to challenge any such amounts estimated by XAPL, and settle them on the spot.
- ### 5 Disclaimer:

I the undersigned, hereby declare that I fully understand and appreciate the nature of adventure sport/activity I am about to undertake and the risks that such activity/activities entail. Accordingly, I hereby renounce to make any claim by legal action or otherwise, either personally or through third parties on my behalf against XAPL or its partners for any injury, loss/damage, accident or death that I may suffer personally or to my belongings while undergoing the activity/activities or otherwise at Xcapade Adventures. I hereby indemnify and undertake to keep indemnified XAPL, and covenants with XAPL, that in the event of XAPL, due to my undertaking the above event, suffers or incurs any loss, costs, charges, expenses, liability because of claims or litigations initiated by third party, due to that, then I shall make good the said loss, costs, charges, expenses, liability that XAPL may incur or suffer on the said account.

6 Caveat:

XAPL or any of its directors/employee/partners/staff shall not be responsible or in any way be liable, in the event of activity/activities not being undertaken for reasons beyond their control, including but not limiting to fire, earthquakes, floods, epidemic, war, civil disturbances, sanctions, government approvals, rains etc.

7 Termination:

XAPL may at its sole discretion terminate this agreement in the event you violate any or all of terms of this agreement, any of the rules, regulations of XAPL or do not follow the advise/instructions given by the XAPL instructors/employees/partners/staff or any declaration made by you if found untrue or any other reasons as deemed fit by XAPL. Further XAPL may terminate this agreement without assigning any reasons anytime before or during activity/activities.

8 Notices:

XAPL shall be entitled to send any notice to you by registered post AD to your address last known to us. Any notice sent by us shall be deemed to have been received by you in three (3) days after the date of posting.

9 Jurisdiction:

You hereby unconditionally submit to the jurisdiction of the courts in Ajmer in the event of any dispute regarding interpretation of this agreement or any other dispute between the parties.
